Abilities required

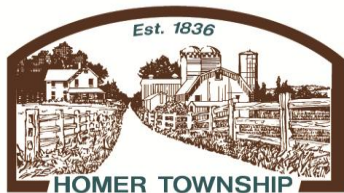
- Ability to perform manual labor and heavy lifting (approx. 50 lbs)
